This letter is given to you as a courtesy to assist you in making disposition of your offense(s). If you wish to contest your offense(s), a plea of NOT GUILTY must be entered in writing or in person on or before the report date shown on your citation. You will be notified of your court date.

A plea of GUILTY/NO CONTEST waives your right to trial. Payment must be in PERSON or MAIL, must be POSTMARKED on or before the report date shown on your citation. **Acceptable Fines are found on the reverse side of this form. Submit payments on or before report date by money order or cashier's check. NO PERSONAL CHECKS ACCEPTED.**

Expired Drivers license and/or Expired Inspection (MVI) Certificate offenses may be dismissed with proof of renewal and a \$20.00 administrative fee **on or before the report date on citation.** Expired Vehicle Registration offenses may be dismissed with proof of renewal and payment of a penalty and a \$20.00 administrative fee **on or before the report date shown on your citation.**

**FAILURE TO RESPOND BY REPORT DATE MAY RESULT IN A VIOLATE WRITTEN PROMISE TO APPEAR BEING FILED AND WARRANTS. A \$50.00 WARRANT FEE IS ADDED TO EACH OFFENSE AS OF 9.1.99. A \$25.00 TIME PAY FEE IS ADDED TO ALL DELAYED PAYMENTS OF ADJUDGED FINES.**  
**A \$30.00 OMNI FEE IS ALSO ADDED AND YOU MAY BE DENIED RENEWAL OF YOUR DRIVER'S LICENSE.**

**DRIVING SAFETY COURSE AND DEFERRED DISPOSITION INFORMATION**

A speeding offense, not in excess of 24 miles over the speed limit, and other various traffic violations may be dismissed by taking Driving Safety Course (See requirements below) with PERMISSION from the Wills Point Municipal Court as follows:

- (1) PAYMENT OF COURT COSTS & FEE (speeding \$.112.00, speeding in school zone \$137.00, charge(s) other than speeding-call court) – CASHIER'S CHECK OR MONEY ORDER ONLY, ADDRESSED STAMPED ENVELOPE FOR RETURN OF DRIVING SAFETY COURSE ORDER. Make a written request and submit your fee, plea, self-addressed stamped envelope, and insurance in person or postmarked no later than your report date. **A phone call does not qualify as an appearance or a request.**

- (2)  **I HEREBY REQUEST A DRIVING SAFETY COURSE** as a means to dismiss the offense issued against me & waive my right to a speedy trial. **I have a valid Texas Drivers License.** I have not taken the driving safety course within the past 12 months in lieu of payment of a fine and I am not currently taking a course for another citation.

ENCLOSE PLEASE FIND:

- GUILTY/NO CONTEST (circle one) must be entered (except for juvenile)  
 FEE ENCLOSED (cashier's check or money order)  
 PROOF OF FINANCIAL RESPONSIBILITY (insurance card)

I understand I will be responsible for scheduling and paying for a State Approved Course, I will be expected to supply to the Court a CERTIFIED COPY OF MY DRIVING RECORD obtained from the Department of Public Safety in Austin which will reflect all courses taken in the past and a numbered CERTIFICATE OF COMPLETION of the course during the 90 day deferral period.

- (3)  **I HEREBY REQUEST DEFERRED DISPOSITION** as a means to dismiss the offense issued against me and waive my right to a speedy trial. I am remitting my court cost (**contact the court for court cost amount**) along with this form. I must not receive another citation within my 30 (thirty) day probation. I understand that I am responsible to contact the court for my deferral due date. At the end of my probation I will submit to the court a special fee, (which the court will notify me of when I pay my court cost), along with a notarized affidavit stating no other violations. **A person under the age of 25 will be on a 90 (ninety) day probation and must take a drivers safety course during the first 60 (sixty) day of probation.**
